Guest Speakers: Lance and Kirsten Gray



This is our newest presentation based on over twenty years of fishing the “Hex” at Lake Almanor. This great fishery offers anglers a chance to catch big fish on big dry flies. It’s a great way to spend an evening fishing on the lake. The presentation will illustrate how to breakdown the lake, flies, rigging and personal safety while fishing.

Lance and Kirsten have more than 50 years combined experience in fly fishing. Lance started fly fishing with his father and brother Lincoln at age 7. In his teens, he began tying flies commercially for shops all around Northern California. At 17, he went to work at Powell’s in Chico, working in the fly shop and building rods. He guided for Powell’s, conducted fly-tying and fly-fishing schools, and traveled.

In 1993, Lance and Kirsten started Saltwater Innovations, a company that manufactured and distributed products for saltwater fly fishing. Lance’s Crystal Popper, Gray’s Billfish Fly, the KO Charlie line and the Raghead Crabs are all Saltwater Innovations products. Kirsten worked behind the scenes, handling the day-to-day operation running the manufacturing floor of the company.


In 2003 they launched Lance Gray & Company, a full-service outfitter offering guided trips, fly-fishing schools, workshops and a travel agency. Lance conducts presentations at fly clubs and outdoor shows and supports local groups like Cub Scouts and 4H. He’s a signature tier for Aqua Flies, pro staff member for Sage and Rio and is a featured writer, with articles published in *Angling Trade Magazine*, *California Fly Fisher*, *Fly Fishermen*, *Sierra Fisherman* and *Northwest Fly Fishing*.

President's Line


Is It Spring Yet?

We have a number of things to discuss as we leave our record-breaking wet winter behind, leaving all the reservoirs full and overflowing with strong river flows that are beginning to subside. I was in the process of building an ark just as the rain began to slow down. It's hard to imagine Highway 17 closed and San Jose-Soquel Road destroyed! The snowmelt may impact the rivers again.

Locally the surge of newly liberated Carmel River wiped out the newly planted willows, which were part of the San Clement Dam removal and restoration. If enough of you are interested, I believe we can arrange an information tour of the river with an explanation of the Dam removal process and the subsequent flows. Let me know by emailing me and we can plan the tour.

We have a number of new fishouts planned, including Mark Traugott's upper Yuba trip on land controlled by the



University of California providing limited, controlled access, which he has been able to obtain. Should be an interesting trip exploring this part of the Yuba, which is not generally available to fish.

Speaking of the

Yuba, We have a new overnight shad trip on the Yuba, June 6th and 7th, with guides in aluminum boats, and walk and wade fishing. From current preliminary river flow information, the Yuba should be reasonable in June..

Tom Peirano, out of Stockton, is offering two one-day trips for two anglers each on the Delta for stripers. The retail cost is \$500; minimum bid is \$275. He is also offering a one-day trip for two anglers on both the American River and the Feather River for trout and/or shad. The retail cost is \$450; minimum bid is \$250. Lincoln Gray, out of Chico, has set up a two-day drift trip for two anglers on the Lower Sacramento River. No lodging is provided. Retail cost is \$900; minimum bid is \$500. The Environmental Protection Agency is on the verge of catastrophic cuts that will put ecosystems and human health at risk. These cuts will end cleanup efforts of destroyed ecosystems. Often, these efforts come alongside state projects. Now the states will struggle with how

Nimbus Hatchery Releases 420,000 American River Steelhead

Nearly a half million young steelhead recently started their journey to the ocean, thanks to the California Department of Fish and Wildlife (CDFW). Staff at Nimbus Fish Hatchery nursed the young steelhead through several potentially devastating conditions, including drought-induced high water temperatures in the hatchery last summer and winter flood conditions that nearly cut off usable water supplies and carried dangerous levels of silt into the hatchery's normally clean water distribution system. "The fish we released will be returning to the American River over the next two to four years, and we are proud and relieved to have brought them this far," said Gary Novak, the Nimbus Hatchery manager. "Steelhead are hardy, but considering their size and the number of environmental obstacles cropping up in rapid succession, they still needed human intervention in the hatchery to ensure a better chance of survival in the wild."

All 420,000 young steelhead were released into the American River just upstream of the I Street Bridge in Sacramento. Due to the high water conditions, the juvenile fish are expected to make excellent time traveling down the Sacramento River to the Bay and eventually on to the Pacific Ocean. Losses to predators are believed



to be lower during turbid water and high flow conditions.

During January and February 2017, water releases from Nimbus Dam reached 80,000 cubic feet per second (cfs), which is well above the normal 6,000 to 10,000 cfs. The high flows created conditions that dislodged exceptional amounts of debris, clogging the intake structure at Nimbus Fish Hatchery and creating near-lethal levels of nitrogen in the water. Hatchery staff worked around the clock over a month-long period to keep the water intake open, clear water distribution points, tanks and raceways of silt, and install aerators to lower nitrogen levels.

Fish health assessments by CDFW pathologists found the steelhead to be in satisfactory condition and near the average weight for fish their age prior to release. It remains to be seen how the stressors of living in turbid water and enduring some periods of high nitrogen levels will affect the fish. Annual returns of mature steelhead to Nimbus Hatchery have varied widely in recent years, from a high of 3,409 in 2013 to a low of just 150 the following year. All the fish in this release were marked with an adipose fin clip.

CDFW Releases First Million of Evacuated Fish into Feather River

The California Department of Fish and Wildlife (CDFW) in cooperation with the National Oceanic and Atmospheric Administration (NOAA) National Marine Fisheries Service (NMFS) released one million state and federally listed threatened spring-run Chinook salmon into the Feather River on Monday, March 20.

These were the first fish to be released that were evacuated from the Feather River Hatchery in Oroville on Feb. 9, when the water became dangerously murky following the failure of the Oroville Dam spillway. The fish were moved to the Feather River/Thermalito Annex Hatchery and held there until conditions improved.

"Based on the weather forecast and current reservoir storage, we are anticipating high flows in the Feather River for some time," said CDFW Senior Environmental Scientist Colin Purdy. "Releasing these fish now should allow them to imprint on Feather River water and move downstream before flows drop back down to normal levels."

Central Valley spring-run Chinook are a state and federally listed species and their abundance has declined considerably during the recent drought. The Feather River Fish Hatchery plays



a key role in the state's efforts to propagate this unique run of Chinook salmon.

"Today's fish release marks the success of federal and state agencies coordinating and managing valuable resources while ensuring public safety during a crisis situation," said

Howard Brown, NOAA Sacramento River Basin Branch Chief. "NOAA Fisheries remains deeply concerned with the damage of the Oroville spillways and is committed to reducing further threats to California communities and ecosystems."

"This is another example of the extraordinary multi-agency effort to respond to this unfortunate incident," said California Department of Water Resources Acting Director Bill

Croyle. "We will continue to work closely to protect the Feather River and its fisheries."

Of the fish that were evacuated, another million spring-run Chinook and three million fall-run Chinook remain at the Annex Hatchery. CDFW and NOAA fisheries staff will continuously evaluate the remaining salmon and begin planting them in northern California Rivers when the fish are mature enough.

GEARING UP

Westlake Park - April 6th, 3:00 p.m until dark.

FishMaster: Elaine Cook - 688-1561

This Santa Cruz pond is open to kids under 16 and seniors 65 and older. It's a small pond that holds bluegill. We will do some casting using poppers, then see if we can catch a fish or two from shore. **Gear:** A 5 or 6 wt. rod with weight forward line, leader (4 feet of 20 lb. Maxima the 2 feet of 10 lb. Maxima), and poppers, small Clousers, weighted Buggers, or nymphs. Glasses and sunscreen will also be needed. Some gear is available for beginners. Please call Elaine at 688-1561 if you will need a setup.

Directions : North on Hwy 1, turn right on High Street. Then turn left on Moore Street and left on Bradley. Go to the far side of the pond and look for the red Bronco car.

There are no restroom facilities. Bring water and snacks/food.



Roostercomb Ranch Bass Fishout - Dates: April 21-23 and May 5-7, 2017

This year there will be two SCFF Club fishouts to the Roostercomb Ranch. This is an excellent fishout for beginners, so don't be intimidated for lack of skill, experience or equipment. It's also a great place to get away from it all and do hiking, birding ATV-ing all over the ranch, or just kicking back. Each is a 3-day, 2-night trip. The Roostercomb Ranch is located in Stanislaus County bordered by private ranches and the Henry Coe State Park, 22-miles on dirt road from Casa de Fruta Restaurant in Hollister. **Note:** We will caravan together to the ranch on Friday morning and out from the ranch on Sunday late afternoon.

This 5,800-acre ranch offers 9 ponds stocked with bass and blue gill for fishing from float tubes and from shore. Housing will be available in both the bunk house and ranch house, or you can

camp. Meal groups will be organized for breakfast and dinner only. Lunches, snacks and beverages are individuals' responsibilities. Due to the heavy rains, rugged dirt roads, and high water in the streams, transportation in and out of the ranch is required with 4-WD vehicles only!...NO all-wheel drive vehicles at this time for April trip. Arrangements can be made for those without 4-WD to ride with someone who has. Let me know when you call in if you need transportation. Each trip will be limited to 16 fishers with a minimum of 10 persons, fishing or not. For more details, you can contact me.

Green River Fishout- July 8-15

Fishmaster: John Steele - 476-0648

The Green River Fishout is scheduled for July 8th through July 15th, 2017. This river is a tailwater of the Flaming Gorge Reservoir Dam, situated in the northeast corner of Utah. It carves its way through a spectacular red rock canyon, and is the home of a healthy number of large brown and rainbow trout. It is rare to catch one under 16 inches, and not uncommon to catch several over 20 inches. You can walk a well-maintained trail along the river and bank fish, and/or book a guide to drift the river. The Trout Creek Flies and On The Fly guides are all very competent, excellent teachers, and provide all your terminal tackle, plus a delicious riverside lunch.

At the present time, lodging for the Santa Cruz Fly Fishermen group has not yet been firmed up, but John has reserved rooms at Trout Creek Flies Lodge, which has cabins that can accommodate up to four fishers each, and have mini-fridges and microwaves, and there is an on-site restaurant. There are other lodging options in the area, namely, Flaming Gorge, (435) 889-3773, and Red Canyon Lodge, (435) 889-3759.

More information will be available later on, when we ascertain the status of the accommodations, however, if you intend to go on this fishout, it would be a good idea to let John know, so he can determine how many rooms we will need, and also to schedule guides.

Kids and grandkids are especially welcome, so bring


them along. They are the future of both fly fishing and conservation, so it's important to expose them to the sport. This event is

Preventing Tick Bites on People

- * Avoid Direct Contact with Ticks
- * Avoid wooded and brushy areas with high grass and leaf litter.
- * Walk in the center of trails.
- * Repel Ticks with DEET or Permethrin
- * Use repellents that contain 20 to 30% DEET (N, N-diethyl-m-toluamide) on exposed skin and clothing for protection that lasts up to several hours. Always follow product instructions. Parents should apply this product to their children, avoiding hands, eyes, and mouth.

Use products that contain permethrin on clothing. Treat clothing and gear, such as boots, pants, socks and tents with products containing 0.5% permethrin. It remains protective through several washings. Pre-treated clothing is available and may provide longer-lasting protection.

Other repellents registered by the Environmental Protection Agency (EPA) may be found at Insect Repellents: Use and Effectiveness .

- * Find and Remove Ticks from Your Body
- * Bathe or shower as soon as possible after coming indoors (preferably within 2 hours) to wash off and more easily find ticks that are crawling on you.

- * Conduct a full-body tick check using a hand-held or full-length mirror to view all parts of your body upon return from tick-

infested areas. Parents should check their children for ticks under the arms, in and around the ears, inside the belly button, behind the knees, between the legs, around the waist, and especially in their hair.

* Examine gear and pets. Ticks can ride into the home on clothing and pets, then attach to a person later, so carefully examine pets, coats, and day packs.

* Tumble dry clothes in a dryer on high heat for 10 minutes to kill ticks on dry clothing after you come indoors. If the clothes are damp, additional time may be needed.

If the clothes require washing first, hot water is recommended. Cold and medium temperature water will not kill ticks effectively. If the clothes cannot be washed in hot water, tumble dry on low heat for 90 minutes or high heat for 60 minutes. The clothes should be warm and completely dry.




FLY OF THE MONTH

Rusty Squirrel Clouser Submitted by Elaine Cook

It's that time of the year to start fishing our local surf for those surf perch and stripers. We have several Club members who pursue these fish and introduce other Club members to this type of fishing. Kirk, our Newsletter Editor, indicates this is one of his "go to" flies. It can be tied in a variety of colors and sizes for different uses.

Hook: TMC 800s or similar such as Mustad 34007, sizes 4 - 6
Thread: Red 6/0
Eyes: Spirit River Real Eyes or other barbell eyes, size 3/8
Tail: Natural or Brown Squirrel
Body: Gold diamond braid
Belly: Squirrel
Wing: Squirrel and Rainbow Krystal Flash



1. Crimp barb.
2. Attach thread behind eye, wrap to mid shank with touching wraps. Advance thread to 1/3 back on shank.
3. Attach eyes to top of shank with criss-cross/figure 8 wraps and wraps that encircle around the base of the eyes. Apply SuperGlue to the thread wraps.
4. Cut clump of squirrel from tail the size of a wooden match stick. Clean out underfur. Tie to top of shank up to the barbell eyes so that the tail extends a hook-shank length beyond the shank. Apply SuperGlue to the tie-down thread on shank.
5. Tie in braid at rear of shank. Advance thread to behind barbells. Wrap braid forward in touching wraps. Tie off and cut excess.
6. Cut and prepare clump of squirrel as above. Position butt ends behind hook eye, tips extending a little short of the tail. (see diagram) Tie in place back to barbells. Tie squirrel down behind barbells with 5 - 6 thread wraps and make one half-hitch.
7. Turn hook upside down in the vise. Advance thread to in front of barbells.
8. Cut and prepare clump of squirrel as above. With tips extending as far as belly, tie in butt ends between barbells and hook eye.
9. Cut two strands of Krystal Flash into four pieces each and stack. Tie in center of bundle behind hook eye. Fold forward fibers back. Tie in place. Tie thread nose. Whip finish, cut thread. Apply SuperGlue to nose.

RECIPE OF THE MONTH

Lemon Baked Cod From <http://www.food.com/>

Ingredients:

1 lb cod fish fillet
1/4 cup butter or 1/4 cup margarine, melted
2 tablespoons lemon juice
1/4 cup all-purpose flour
1/2 teaspoon salt
1/8 teaspoon white pepper
paprika


Directions:

1. If fish fillets are large, cut into serving pieces.
2. Mix butter and lemon juice.
3. In another bowl, mix flour, salt and white pepper.
4. Dip fish into butter mixture; coat fish with flour mixture.
5. Place fish in ungreased square baking dish, 8x8x2 inches.
6. Pour remaining butter mixture over fish; sprinkle with paprika.
7. Cook uncovered in 350 degree oven until fish flakes easily with fork, 25-30 minutes. Garnish with parsley sprigs and lemon slices if desired.
